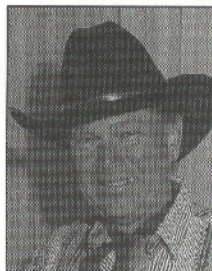
Meet Your New President – Harold Thornton

Harold attended the University of Oklahoma in the glory days of OU's football team, graduating in 1957 with a Bachelor of Science in Geological Engineering. While there he was the only engineering student also taking vocal lessons for credit, a result of his mother Mona's

musical influence. His petroleum career has been in supervision and management of drilling and production operations, primarily in Alberta, but as far afield as Quebec, the Maritimes and Texas.

Harold and his wife Dolores, although both city raised, were heavily involved in the purebred beef cattle industry for 20

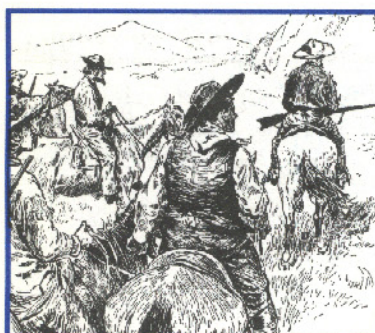

Hiram Cody Jr., Long Time Treasurer, Steps Down

One of the sidebar stories of the 1996 Cody Reunion at Cody WY in July was the gathering of 35 members of the Hiram Cody family at a nearby dude ranch for the week preceding the reunion. Hi and his sister, Rosemary Edwards, spent much of their time meeting airline arrivals. Said Hi: "It was worth it. We had my sister and all of our children and grandchildren together in one place. It probably won't happen again."

At the Cody Family meeting, Hiram turned over the treasurer's chores to Margaret Mabon. He had previously delivered the inventory of Cody books and articles to headquarters in Massillon. Hiram S. Cody Jr. followed the footsteps of his father Hiram Sedgwick Cody in serving well the International Cody Family Association. The elder Hiram was on hand when the fledgling organization was formed in Chicago in the early twenties.

Hiram Sedgwick Cody Jr. was born in Evanston IL on November 11, 1915. As a teen-ager, he relocated with his family to Asheville NC where he completed his

secondary education at Asheville School. He later served twelve years as trustee and treasurer and chairman of the Finance Committee for the school. He graduated from Yale University in 1937 with a bachelor's degree in Business Administration. In 1940, he received his law degree from Yale and was admitted to the North Carolina bar in that year. Hiram entered active service with the U. S. Navy on May 12, 1941 and was discharged with the rank of Commander in 1946.

He began his career with "Ma Bell" in June 1946 and retired in December 1980 from the office of assistant treasurer of AT&T, having previously served as secretary-treasurer of Western Electric Company. He sought out his boyhood home for retirement and now lives in Black Mountain NC.

In 1941, Hiram married Mary Vaughn Jacoby of Wilmington DE. She was born in Welland ON and graduated Phi Beta Kappa with honors from Mount Holyoke College. She did graduate work at Union

Theological Seminary and Southern Methodist University School of Theology. She was director of religious education at Grace Methodist church in Wilmington at the time of their marriage.

Hiram and Polly's family include Margaret Cody Komives of Fort Collins CO, Judge Harriet Cody of Seattle, Dr. Hiram Sedgwick Cody III of New York City, Henry Cody of Seattle, and Dr. William Collins Cody of Moorestown NJ. They have eight grandchildren.

Hi's brother Bill, drowned at Miami FL while serving as a sergeant in the Army Air Corps in 1944. His sister, Harriet Rosemary Cody Edwards married the Rev. Tom Edwards in 1944 and they have four children. Rosemary served as assistant to Mary Jester Allen at the Buffalo Bill Museum in Cody in the summer of 1937 while it was still an activity of the Cody family. Her favorite memory was that of meeting Bronco Charlie Millar, the last surviving Pony Express Rider and a performer in Buffalo Bill's Wild West.

The Longest Ride

Almost the very first person I saw after dismounting from my horse was Slade. I walked up to him and presented Mr. Russell's letter, which he hastily opened and read. With a sweeping glance of his eye he took my measure from head to foot, and then said "My boy, you are too young for a pony express rider. It takes men for that business."

"I rode two months last year on Bill Trotter's division, sir, and filled the bill then; and I think I am better able to ride now," said I.

"I have heard of you before. You are a year or so older now, and I think you can stand it. I'll give you a trial anyhow and if you weaken you can come back to Horseshoe Station and tend stock."

The next day he assigned me to duty on the road from Red Buttes on the North Platte, to the Three Crossings of the Sweetwater - a distance of 76 miles. It was a long piece of road, but I was equal to the undertaking; and soon afterwards had an opportunity to exhibit my power of endurance as a pony express rider. One day when I galloped into Three Crossings



I found that the rider who was expected to take the trip out on my arrival had got into a drunken row the night before and had been killed; and that there was no one to fill his place. I did not

hesitate for a moment to take an extra ride of 85 miles to Rocky Ridge, and I arrived at the latter place on time. I then turned back and rode to Red Buttes, my starting place, accomplishing on the round trip a distance of 322 miles. (Editor's note: This ride is claimed to be the longest continuous ride ever made by a Pony Express rider).

Slade heard of this feat of mine, and one day as he was passing on a coach he sang out to me, "My boy, you're a brick, and no mistake. That was a good run you made when you rode your own and Miller's routes, and I'll see that you get extra pay for it."

(Buffalo Bill) Cody and the 100th year of the founding of Cody WY. Attendance was good and everyone enjoyed the festivities planned by the Codys of Cody. Special thanks goes to Bill Garlow, Kit Cody and his family and Paul Fees, Director of the Buffalo Bill Historical Center. The weekend was filled with many activities, including a rodeo, in which Jim Cody of Pomona CA led the parade carrying a flag from the Buffalo Bill Historical Center and our family's attendance was acknowledged.

For many family members, the tour of the Buffalo Bill Historical Center was a highlight of the reunion. Paul Fees guided family members through parts of the Center normally not open to the public.

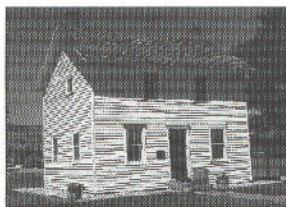

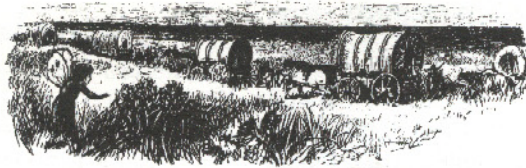

Deaths

Ralph Gratton Gage (270/1312), 81, of Stockport Ohio, died on January 3, 1996. He is survived by his wife, Maudie Slayton Gage, four sons, Ralph H. Gage of Missouri, Jerry L. Gage of Canton, OH, Richard R. Gage of Beverly, OH and Danny L. Gage of Bartlett, OH; two daughters, Susan L. Gage of Stockport and Sheri R. Gage of Marietta; 10 grandchildren, four great grandchildren and a brother, Alva Gage of Stockport. Mr. Gage was born at Pattins Mill, Ohio and graduated from Bartlett(OH) High School. He served in the Navy during World War II. He was a welder-pipefitter and traveled to many states working on pipeline construction and lived in North Dakota for 10 years working for Oil Field Service. In later years, he purchased the Horace Gage farm at Wolf Creek in Washington Co. near Dale OH. While living there, he bred horses, mostly Appaloosas, Having up to forty at one time. Later, he turned to farming and raising cattle and running a service station in Bartlett. Mr. Gage had to give up some of his activities when he developed prostate cancer, but was still able to go to Alaska and weld on the Alyeska pipeline. Ralph Gratton Gage is buried in Bartlett Cemetery.

Murray Glazier Child (131/4252) passed on May 23, 1996 in his 80th year. He leaves his wife, Verva McGillivray, and children Ronald Child and spouse Kathleen McMullan of Toronto, Karen and spouse Michael Kirkwood of Bermuda and Gordon Child of Red Deer Alberta. He will be remembered by his grandchildren Jennifer and Kathryn Child of Toronto, Rebecca and Briana Kirkwood of Bermuda and his brother Harold Child and spouse Sybil of Matheson. Mr. Child served with the Canadian Armed Forces during the Second World War, from 1940 until 1945. He worked as the Manager of Regional Audit for the Department of Highways for 38 years, retiring in 1972. His final resting place is at Balsover, Ontario.

years, raising Charolais cattle on their 1000 acre ranch east of Calgary. Running between 200 to 300 head of cattle, the family successfully showed and sold their stock not only into the substantial local market, but across Canada and south as far as Texas. As well as his direct involvement in the day to day work of the ranch, and his continuous involvement in the oil business, Harold spent nine years on the Board of the Canadian Charolais Association, and was President in the late 70's. Prior to that, Dolores was President of the Canadian Charolais and pioneered a program raising consumer awareness of the nutritional benefits of beef.

Harold was a Director of the Calgary Exhibition and Stampede for 15 years and is now an Honorary Life Director. The Calgary Stampede is known as The Greatest Outdoor Show on Earth. Started in 1912 by an American cowboy promoter named Guy Weadick, it is a direct descendant in spirit, style and content, of Buffalo Bill's Wild West Show. Over the years, Harold was Director responsible for nearly half of the fifty two committees, composed of some 1800 volunteers, that put on the Stampede, plus other year-round events.

Finally in 1988 Harold found a paying Board job. He was appointed Chairman of the Alberta Agriculture Development Corporation (ADC). The ADC is a Crown (government) corporation that has loaned about a billion dollars to farmers and agribusinesses in Alberta. ADC was merged in 1994 with the Alberta Hail and Crop Insurance Corp. to become the Agriculture Financial Services Corporation. Harold helped with the transition and chaired the new Board.

Harold is currently Vice President, Production of the Wiser Oil Company Canada Ltd. in Calgary. Wiser is over 90 years old and headquartered in Dallas. The exploration and production part of the oil industry is a complex and fascinating business. Harold says, "It's fun to go to work in the morning, to be part of the finding and development of new oil reserves. It has been said oil is found in the minds of men and women. After all these years I still get a great thrill out of being part of a team that finds it!"
