Rides, cruise highlight weekend event

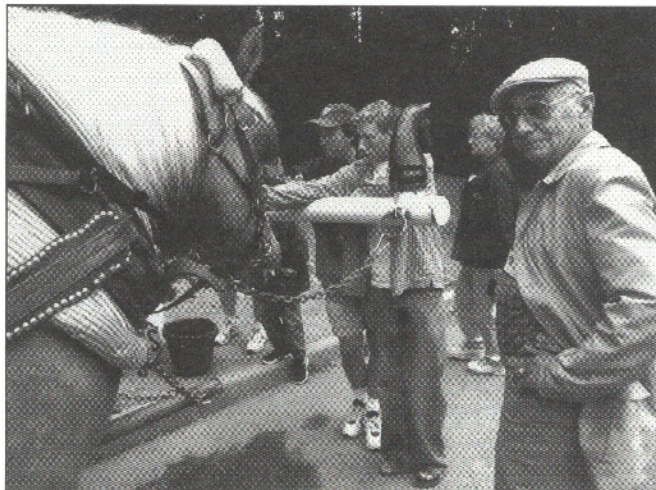

Executive Committee Minutes

**Canyon Court Motel,
North Vancouver, B.C.
Friday, Aug. 25, 2000**

Present: Kit Cody, Suzanna Cody, Terry Cody, Leland Norwood, Margaret Mabon, Richard Grosenbaugh, Hiram Cody, Gerald Cody, Jim Cody, Harold Thornton, Allan Cody,

...

Kit opened the meeting by reading the minutes of the previous meeting in Worcester, MA. Discussion ensued through the reading as follows:

The website did not get off the ground in the past period, but will for sure now. A committee of Terry Cody, Richard Grosenbaugh and Allan Cody will design and install a suitable website, under the oversight of Kit Cody. Inquiries to the website will be handled by Lee Norwood and Terry Cody.

Margaret Mabon indicated her desire to decrease her work load. A few possible replacements were discussed and a two year transition period was suggested and agreed upon. Certain seeds were to be sown and watered by Kit, with results to be circulated later.

...

Cody Foundation 501 C status will be once again investigated by Suzanna Cody and Gerald Cody, with a view to obtaining that U.S. tax status, which would greatly enhance fund raising by allowing the issuance of tax receipts. Previously the status could not be obtained because of the organization's focus on the genealogy. There may be a way to open the membership to non-family members, or to create two separate entities to obtain the status.

...

Future Reunions discussed, with the following schedule confirmed from the prior reunion:

November 14 to 17, 2002, in Florida, to be organized by Kit and Linda Cody, with help from others in the area.

California, (in San Diego or possibly Palo Alto areas) with Jim Cody and Suzanna Cody organizing. Timing and place to be announced in 2002.

Cody, Wyoming. Looks like Kit and Linda again. (2006)

...

The frequency and content of the *Review* was discussed at length, with the decision to have the following deadlines:

Date for editorial content to be in
November 15
May 1

Date for publication/ mailing
January 15
June 15

The issue immediately following a Reunion will report on that Reunion, creating the (correct) impression of how much fun was had by the attendees. The two issues prior to the next Reunion will concentrate on its promotion. It is recognized that the *Review* is crucial to good attendance.

...

A line of modernized Cody merchandise was suggested by Harold. For example, hats, tee shirts, jackets, jewelry, etc. Gerald Cody seemed particularly interested, and indicated that he and Marilyn would investigate and report back to Kit. Allan Cody suggested care be given to copyright or trademark of any images used.

...

A reprinting of 25 copies of the *Genealogy* was authorized by motion, M/S/C.

...

Re-printing of the "Five Generations" book by Lydia Cody was discussed. Richard and Terry will investigate the feasibility of doing so either electronically or by photocopy.

...

A subsequent meeting was held after the Bi-annual General Meeting, in which the same topics were briefly reviewed and the above details confirmed.

In addition, after some discussion on the nature of the organization's structure, it was decided by motion M/S/C that Terry Cody be given the title and responsibilities of Executive Director. Terry will be responsible for management of the database, replying, along with Lee Norwood, to inquiries on the website, handling of direct mailing from the membership and forwarding of that mail to the appropriate officer.

...

It was agreed by motion M/S/C, that a new category of membership be created, called Associate Member, with an annual dues payable of \$10.00 U.S., and such membership will include the *Review*. Further, an Active Member, with an annual dues payable of \$25.00 U.S. will receive the *Review* plus a membership card. The card will include an expiration date based on the calendar year.

...

It was suggested that a middle year executive meeting between Reunions could be desirable to further the work of the association. Agreement in principle was given to a gathering in Florida about February, 2002. Kit will set a time and place, notify participants and send them their free tickets. (Just seeing if you're reading these minutes.)

Editorially Speaking

This has really been "Buffalo Bill Year" in my life.

I've had an increased interest since I stumbled across a small Cody museum in LeClair, Iowa, Buffalo Bill's birthplace. This led me to visit another Iowa dwelling where he is reported to have lived before the family moved to Kansas.

Several winters ago, I visited the Scout's Rest Ranch in North Platte, Nebraska, and Buffalo Bill's grave on Lookout Mountain.

This summer on the way to the reunion in Vancouver, I stopped again at North Platte (this time the house was open) and at the Buffalo Bill Historical Center in Cody, Wyoming. I even got to stay in the famous Irma Hotel.

Because I am assimilating everything I can about our famous relative, I've been browsing used book stores. I've found a copy of Cody's autobiography, the books by Nellie Snyder Yost and Don Russell and a copy of "My Life with Buffalo Bill" by Dan Muller which I have since found out was a fraud.

My most interesting find to date, however, is a copy of "The Last of the Great Scouts" by Helen Cody Wetmore. While browsing a small shop in Springfield, Missouri, I found a copy of this classic which was autographed. The autograph read "Good wishes of the author's daughter, Mary Jester Allen - Director, Buffalo Bill Museum - Cody, Wyoming." To that point in time I had not heard about Mary Jester Allen. I soon found out, from various sources, that she was indeed Buffalo Bill's niece and had worked with the Wild West Show as a promoter.

The folks at the McCracken Research Library said that the signature was indeed Mrs. Allen's. It wasn't though until I read the book "From Cody to the World: The First Seventy-five Years of the Buffalo Bill Memorial Association" by Richard A. Bartlett that I realized just how important she was to getting the Buffalo Bill Museum in Cody started and seeing it through its many growing pains. I also learned of her role in getting the International Cody Family Association going in 1925, 75 years ago.

A footnote to my education about this remarkable lady was a paragraph in the Bartlett book that stated: "It is said that she attended Drury College in Springfield, Missouri..." The author says, however, that Drury officials could not find her name in their records. I checked on this myself recently and got the same answer. The question I still have is whether or not my finding this autographed book here in my hometown has anything to do with the fact that perhaps one of Codys actually lived here for awhile.

As I dig deeper locally I am finding more connections between Buffalo Bill and Springfield, Missouri. But those I'll leave for another time. Needless to say, I'm hooked.

FOOTNOTE: Once grasped by the mystique of Buffalo Bill it's hard to get away from him. While in New York recently I saw "Annie Get Your Gun" on Broadway. Who's the first character on stage? You guessed it. Attending a local production of "The Hound of the Baskervilles" in my hometown, the closing line was: "Why don't we go see Buffalo Bill's Wild West Show which is in town."

In the future, you will be able to purchase updated versions of individual Chapters for a nominal fee. Thus, you will be able to update your chapter, or any of the other chapters, of the Genealogy as often as you wish. The updated Chapters will be printed for you from our current family database. In the News

These recent items show that Buffalo Bill Cody is still very newsworthy:

...

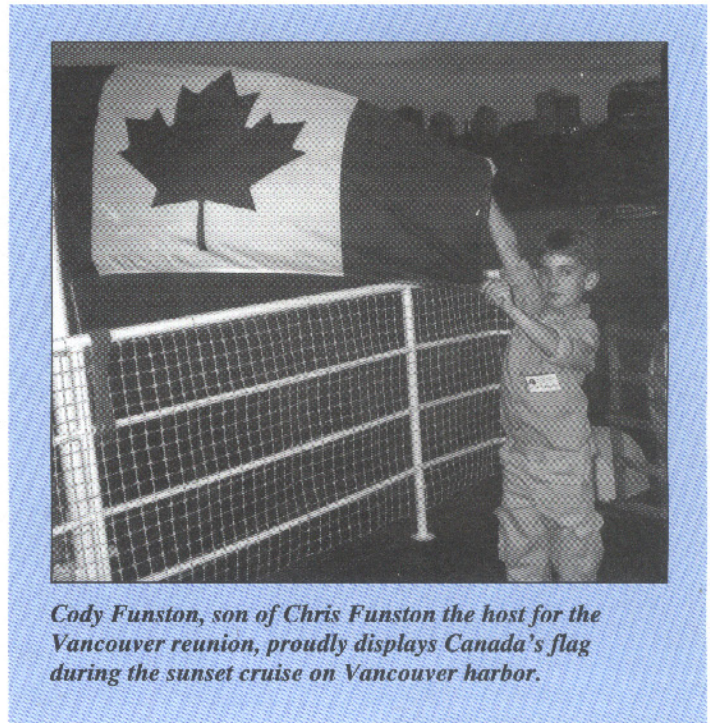
In connection with the 2000 Reunion the North Shore News ran a nice article about the reunion and about Chris Funston his interest in Buffalo Bill, and the Cody connection in Canada. It included a familiar photo of the Scout with Sitting Bull and one of Chris with some of his memorabilia. "He was truly a legend in his own time," Chris told the paper. "But how he went about it and how he treated people was his greatest legacy."

...

The Los Angeles Times published an extensive review on October 1 about the new book, "Buffalo Bill's Wild West: Celebrity, Memory, and Popular History" by Joy S. Kasson. The article by Tom Engelhart starts off: "He was Tom Cruise, Bruce Willis and Mel Gibson. He was Michael Ovitz and Michael Eisner rolled into one; his own publicity machine; his own agency; his own star; his own studio on wheels." It then gives a good summary of the life of Buffalo Bill and how he came to the popularity that led to the Wild West Show being so popular. The article sums up Cody's impact on the nation this way: "By the time he was done, he had invented the West, created the Audience and in a sense laid the foundations for Hollywood."

An article from a Colorado newspaper headlined "Statue shows different side of Buffalo Bill" reports on a new statue unveiled in



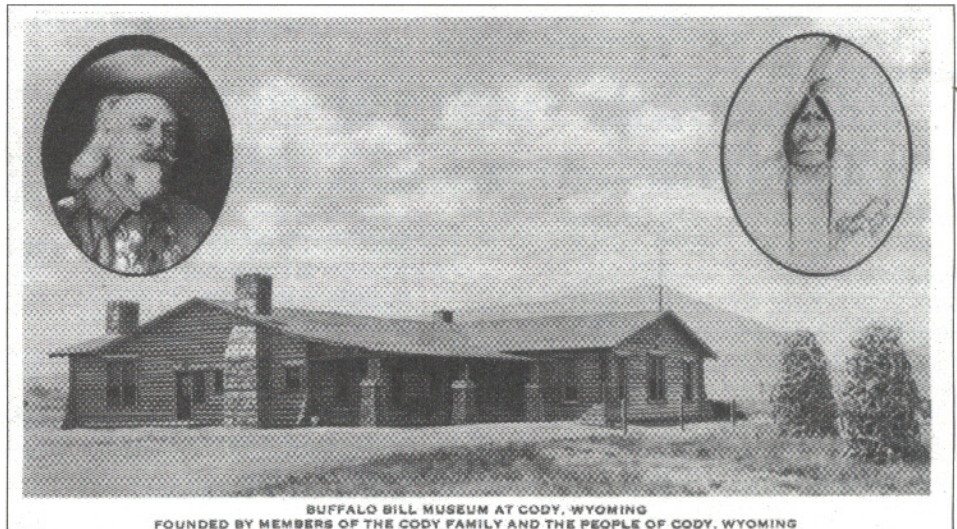
Cody Funston, son of Chris Funston the host for the Vancouver reunion, proudly displays Canada's flag during the sunset cruise on Vancouver harbor.

Centralia Mural

Centralia, Washington, promotes itself as "the City of Historical Murals" and among the 16 large murals located throughout the city is one of Buffalo Bill Cody.

Information on the mural and the accompanying photo was provided by Brenda Bulger from Olympia, Washington.

The description accompanying the mural reads:

"Buffalo Bill, the famous 19th Century buffalo hunter, U.S. Army scout and Indian fighter, whose real name was William F. Cody is the subject of the mural. Cody organized the Buffalo Bill Wild West Show in 1883. On September 14, 1910 he brought his show to Centralia."

Kathy Evans was the artist for the reproduction of one of the Wild West Show's famous posters.

Family previews Buffalo Bill exhibit in Leeds, England

Several members of the Cody family were privileged to be involved in previewing a brand new traveling exhibit put together by the Buffalo Bill Historical Center.

This collection of memorabilia included the original Deadwood Stage along with hundreds of items that told the life story of Buffalo Bill. The exposition first opened in Leeds, England at the Royal Armories Museum. Kit and Linda Cody, Susanna Cody, and Ron Hill attended as representatives of the Cody Family Association. Former senator, Allan Simpson, now chairman of the Board of the Buffalo Bill Historical Center, Bill Garlow and other BBHC board members, Paul Fees and other BBHC staff all helped open this great Exposition!

Prior to the grand review, the Leeds' people put on a Gala with Lords, Sirs, and Lord Mayors from the Leeds area to make a memorable event. Each of four (4) shows would be for approximately six (6) months.

From Leeds, the show traveled to Los Angeles and on to the Tennessee State Museum in Nashville, Tennessee. Kit and Linda Cody along with Kit's brother and his wife, Barry and Katie Cody, attended the Nashville Expo. The event started with a parade, another great Gala dinner and Grand Opening with local dignitaries including the Tennessee Governor. The Exposition is continuing on to Denver, Colorado in January 2001 and then back home to Cody, Wyoming.
