

The event was well-attended and successful because of the many California family members who spent a great deal of time over the past several years making arrangements.



### First Poster Piece Shown; Reg Lenna Gets Funds

Great headway is being made in the restoration of a historic Buffalo Bill billboard discovered on the wall of a building in Jamestown, PA.

A federal Save America's Treasures grant has been awarded to the Reg Lenna Civic Center to restore an 1878 Buffalo Bill Cody billboard. Announcement of the grant last fall coincided with the unveiling of the first conserved segment of the billboard to be shown to the public. Cody Family Association Vice President Suzanna Cody was present for that unveiling.

Upon hearing about the required matching funds needed, Lamar Outdoor Advertising pledged \$8,000 to help ensure that the entire billboard, measuring 24 feet by 10 feet, will be restored. The project to restore the entire billboard will take about two years. The finished billboard will be displayed in the lobby of the Civic Center.

The poster advertised the Cody Combination production of "May Cody or Lost and Won". The first part of the poster restored shows John Young Nelson (also known by his Indian name of Cha-Sha-O-Pogeo) one of the stars of the production.

### FAMILY NEWS



Ross Cody (256/347) was featured in the Veterans Day issue of the Ashland (OH) *Times-Gazette* because, after 60 years, he had just received eight medals

he was awarded during his service with the 101st Airborne Division in World War II. Those medals included a Purple Heart and a Bronze Star awarded for his participation in D-Day and the Battle of the Bulge. During the war Ross also served in Italy and southern France. Why did it take so long to get the medals? Ross said that because he was more worried about just getting out of the Army, he didn't do much about getting all his medals then; he did receive a Purple Heart and a combat infantry medal at the time. He said he didn't really push the matter "because it really didn't mean that much to me." But his family encouraged him to keep trying and a veterans service office in Ashland helped him finally get his due. Part of the problem was that many army service records were destroyed in a fire in St. Louis in 1970. The Times-Gazette article quotes Ross as saying about his service: "I just tried to stay alive when I was in the service. I didn't consider that any of us guys were heroes or anything like that. You just wanted to stay alive."



Mona Thornton, wife of Douglas Choate Thornton (248/A72) and mother of former ICFA president Harold Thornton (248/A721) died in June at the age of 91. She is also survived by a daughter, Lynne Joanne Thornton (238)A722). Mona had attended the 1998 Reunion in Beverly and was on the organizing committee for the 1993 Reunion in Calgary. She had taught school for a number of years in Calgary.

#### Buffalo Bill's Body Back to Cody?

Consultants brought in to help the city of Cody, WY promote its resources suggested, according to the Cody Enterprise, that the city start a public campaign to force Denver to give back the body of Buffalo Bill. Such a campaign, they said, would stir up controversy and generate free national press. Support could come, the consultants said, from signature cards portraying "Denver as a a thief that has stolen your founder", according to Berkeley Young. The Enterprise quotes him as saying: "All they have is his grave. You've got his life." There was no indication in the story if the city council would consider that idea.

"Buffalo Bill was one of those men, steel-thewed and iron nerved, whose daring progress opened the great West to settlement and civilization. His name, like that of Kit Carson, will always be associated with old adventure and pioneer days of hazard and hardship when the great plains and the Rocky Mountains were won for our race. It is eminently fit to commemorate his gallant, picturesque and most useful career by such a monument as you proposed. He embodied those traits of courage, strength and self-reliant hardihood which are vital to the well-being of our nation." - Theodore Roosevelt, commenting on a proposed monument on the Denver grave site.

"His heart never left the great west. Whenever the day's work was done, he could always be found sitting alone watching the sinking sun, and at every opportunity he took the trail back to his old home. The sun setting over the mountain will pay its daily tribute to the resting place of the last of the great builders of the West, all of which you loved and part which you were." - Annie Oakley

## Executive Committee Considers ICFA Business

Several items of association business were discussed during the meeting of the ICFA Executive Council during a meeting at the 2004 Reunion in San Diego, October 9. They included:

- All the present officers agreed to serve for another two years.
- A suggestion was made about moving the next reunion in Cody, WY, from 2006 to 2007 to coincide with the opening of the new museum dedicated to Buffalo Bill at the Buffalo Bill Historical Center. The change was not approved. The Council did approve a motion that the 2006 Reunion in Cody be held during the Fourth of July period because of the many activities during that time of year. The 2008 Reunion will be held in Ohio; North Platte, NE, or Toronto ON, Canada were mentioned as possible venues for the 2010 Reunion.
- Terry Cody announced the association's web site is up and running at <a href="www.cody-fam-ily.org">www.cody-fam-ily.org</a>. He said that he and Richard Grosenbaugh, <a href="Review">Review</a> editor, would manage the site. Terry also announced that the <a href="Review">Review</a> would be continued in its present six-page format due to rising printing and mailing costs. To help cover those costs, the council voted to increase member dues to \$30 a year.
- Efforts will be made to increase the number of families who pay their dues annually. A system will be set up on the web site that

allows payment of dues. Dues for Canadian family members will be published in the *Review* according to the exchange rates at the time of publication. Dues payments may now be made in U.S. or Canadian dollars. Starting in 2005 ICFA membership cards will be sent to those who pay dues.

- A suggestion was made that the *Review* only be sent to dues-paying members. Terry Cody said, however, that the primary method for keeping family records updated is through the *Review* and that limiting distribution would mean losing contact with some family members.
- It was reported that work is continuing on updating and printing of the Cody genealogy. Hard copies were originally sold for \$100 + \$8 shipping and handling but the price may have to be increased depending on print costs. The family sells the genealogy as a service and does not profit from its sale.
- Suzanna Cody has been working on charitable non-profit status for the ICFA. One option is to explore a formal, mutually beneficial realignment with the Buffalo Bill Historical Center. The officers agreed to meet in Cody WY in late August to meet with the BBHC to conclude any agreement. In the meantime, president Kit Cody and vice president Suzanna will take the lead in discussion with BBHC to prepare the way for the August meeting.

### CODYS IN THE NEWS

Work is going on in Cleveland, Ohio, to save a historic cemetery in the downtown area which contains, in addition to others, the grave site of Philip Cody, father of Isaac Cody and grandfather of William F. Cody. Philip moved his family from Ontario, Canada, to Cleveland in 1832. In his years there he became owner of many acres of land in the center of the city. It was this property that became the topic of a lawsuit filed by Buffalo Bill in 1882. Because of some duplicity on behalf of Philip's son Joseph, Buffalo Bill claimed 55 acres in the center of Cleveland which he felt should have gone to his father Isaac. The court case on the matter dragged on for years; the Great Scout never benefitted from the claim and lost money trying to settle it. Philip spent 20 of his 80 years in that City. The Cleveland Plain Dealer reports that the hidden cemetery lies to the east of East 118th Street, near an expanding Case Western Reserve University. The paper says that responsibility for the graveyard bounced back and forth for almost 100 years between two suburbs: East Cleveland and Cleveland Heights. The place was overgrown with weeds and littered with trash until a new foundation was formed to attempt

The foundation has arranged many free services and is trying to raise grants and donations to restore the cemetery.

### NEWS BRIEFS

It seems that even today many people want to capitalize on the good name and reputation of Buffalo Bill Cody.


A story from Cleveland.com tells about a pair of old cowhide gloves and a damaged horse bridle that were supposedly once the property of Cody which were to be auctioned off. They were said to have been the property of George Tomlinson who reportedly appears with Buffalo Bill on the circuit. The Buffalo Bill Historical Center said there was a man named George Tomlinson who worked with the Wild West. Juti Winchester, curator of the Buffalo Bill Museum, said she felt the quality of the gloves in question were not that which Cody would have bought and that some of the materials seems to be too modern.

In recent publications several people around the country claim, in promoting their business, to be related to William F. Cody. Apparently these claims cannot be substantiated.

The Denver Post carried a story about 83-year-old Helen Eagen who rode a horse six miles up Lookout Mountain to the grave of Buffalo Bill just as she has done every year on the anniversary of his burial. (Although Cody died in December of 1917, his body was not buried until June of the following year.). The article says that Eagen, one of 14 riders who traveled to the grave site, shuffled slowly in her cowboy boots back to her horse, one hand on a borrowed cane and an arm linked through a friends.



Pahaska Tepee near Cody, Wyoming, has just celebrated its 100th anniversary according to an article in the Cody Enterprise. The Pahaska Tepee Resort is an outpost Buffalo Bill built as the third leg of a three-part tourist destination in the area. The other legs were the town of Cody and Wapiti Valley and Yellowstone Park. When it opened a stay at the Pahaska cost \$4 a day, \$15-20 per week. Cody was not present for the opening of the lodge in 1904 because of his Wild West touring. Pahaska was the name given to Cody by Indians. It means "Long Hair". He and other frontier scouts wore beaded buckskins and long hair in deference to native plains people who preferred not to cut their hair.



In May of 2004, a 9,000 pound sculpture of Buffalo Bill Cody was placed atop a manmade hill west of Oakley, Kansas. The sculpture took six years of planning and \$500,000 to complete. Oakley calls itself the "Birthplace of the Legend of Buffalo Bill Cody" because it was near here that Cody killed a record number of buffalo while hunting for the railroad and therefore earned the title "Buffalo Bill". Promoters of the area hope the statue will increase tourist trade. Oakley is just off Interstate 70 between Hays and Colby.



The Nebraska StatePaper.com reports that vandals did more than \$1,500 in damage to the Scouts Rest Ranch house in North Platte formerly occupied by Buffalo Bill Cody. The report says that clubs were used to smash antique Wheelock china and antique glass. Glass littered the floor in the downstairs area of the house. An ornate chandelier was also damaged. The vandals also stole several items from displays. They also struck at the nearby Wild West Arena where a carnival was setting up for Nebraskaland Days celebration. Scouts Rest is now a state park.

The Buffalo Bill Historical Center in Cody is hoping to boost attendance by offering a new family rate and making other changes to lure more people from the Yellowstone National Park area. For \$40 one or two parents plus their children younger than 17 can visit the center under its new family package. Along with fee adjustments, the center is trying group services and projects with Yellowstone National Park's major concessionaire, and also is looking to improve on getting more information out about it in West Yellowstone, Montana, and Jackson. Attendance at the center in Cody dropped almost 7 percent in 2004.

An article in *The Ledger* in Frostproof, Florida, tells the story of the First Presbyterian Church there which is celebrating its 100th anniversary. It mentions Rev. Lindus Cody, "a cousin of Buffalo Bill Cody" as being one of the first members in the church which originally was called the Church Among the Lakes. Lindus was the son of Philip Cody (born 1816) and the grandson of Philip Cody (born 1770). He apparently is also buried in the Cleveland cemetery currently in the news because "Five Generations" reports that both Philip Cody and his wife are buried on the plat of their grandson Lindus in Lake View Cemetery.
